SUMMER CAMP & Before/After School GENERAL INFORMATION

Days and Hours of Operation: Monday-Friday 6:30am - 6:30pm

Any child remaining after 6:30pm will be charged \$1.00 per minute payable when child is picked up.

Admission Requirements: Kid's Clubhouse Summer Camp & Before/After School accepts children who are enrolled to start Kindergarten and up to 12 years old.

Services Provided: Kid's Clubhouse provides an activity bus for all field trips with certified CDL drivers. We also provide a light breakfast of cereal, pop-tarts, milk and juice until 7:30am daily. A mid morning snack is provided on days that the children are out of school and afternoon snacks are also served everyday.

Supplies: All equipment and materials needed for crafts and activities are provided by Kid's Clubhouse unless we advise you otherwise.

Cleaning Duties: We employ a full-time janitor who cleans and vacuums rooms and bathrooms daily and takes out the trash.

Discipline Policy: Any child who repeatedly disrupts or is disrespectful to any child or staff member will be put in Time-Out and if that does not work we will contact the parents. If the behavior continues the child will be suspended from the program. This is to ensure a fun, safe environment for all of us.

Attendance: I understand that I must sign my child out with a staff member daily. If you take your child out without signing them out with a staff member your child may be suspended from the program. You will be charged for the entire week in the School year and the entire Weeks signed up for in Summer.

Notice: You must give 2 week notice in writing for any weeks in Summer camp you wish to drop. **Note: Deposit is Non-Refundable**

Also, you must give a 2 week notice in writing if you wish to drop your child out of the program

Parent Participation: Kid's Clubhouse parents are encouraged to actively participate in our childcare program. Parents with special skills and talents may want to participate/plan activities with the children. Parents may provide special snacks for birthday or holiday celebrations. Parents may also join in the festivities.

Fees: All fees are due Monday and must be paid on time or a \$5.00 late fee will be added for each day you are late. You will not receive credit for unused days. Kid's Clubhouse will charge \$25.00 for returned checks. We will keep a yearly statement on each child for tax purposes. When making a payment please request a receipt. Kid's Clubhouse hours are 6:30am to 6:30pm; any child remaining after 6:30 will be charged \$1.00 per minute payable when child is picked up or before child can be brought back to the Kid's Clubhouse.

Kid's Clubhouse does not employ certified medical personnel. For this reason we are unable to accept children of special needs or on medication.
